



ISSUANCE OF VISA TO KOSOVO* PASSPORT HOLDERS

In accordance with the Rulebook on the procedure for visa issuance in the Diplomatic and Consular Missions of Bosnia and Herzegovina to Kosovo* citizens for entry on the territory of Bosnia and Herzegovina, Embassies of Bosnia and Herzegovina in Skopje, Podgorica and Belgrade are competent for issuing visas to citizens of Kosovo* residing on the territory of Kosovo*.

For the issuance of the short stay visa (visa C) the applicant is obliged to enclose the following:

- **Filled visa application form**
(can be downloaded here: <https://ambasadabih.org.mk/Pdf/Obrazac-zahtjeva-za-izdavanje-vize.pdf>)
- **Invitation letter** which can be one of the following documents:
 - Original invitation letter issued in special form and certified by the competent Field Office of the Service for Foreigners' of Bosnia and Herzegovina (www.sps.gov.ba)
 - Copy of the court or other official summons calling on to take part in a legal proceeding conducted in Bosnia and Herzegovina
 - Original certificate confirming the admission to education or training in Bosnia and Herzegovina.
 - Invitation letter issued by the state or entity authority of Bosnia and Herzegovina, or by diplomatic mission or international organization accredited in Bosnia and Herzegovina and sent directly to the Ministry of Foreign Affairs of Bosnia and Herzegovina.
- **Passport** valid at least three months longer than the period of intended stay in Bosnia and Herzegovina or, in the case of several visits, after the last planned date of departure from Bosnia and Herzegovina. Passport must contain at least two blank pages for visa entry and must have been issued within the previous ten years or that it is of permanent validity.
- **One color photograph**, size 35x45 mm, faithfully showing the passport holder
- **Copy of work contract or other similar document** which proves regular incomes and work engagement (in English, Bosnian/Croatian/Serbian language).
 - For students student ID cards or proofs of studying or similar.
 - For unemployed persons copy of bank statement proving available funds in the place of residence or proof of real estate ownership or proof of integration in the place of residence (household certificate or similar).
- **Travel and accommodation details**
- **Proof of travel health insurance** for the planned period of stay in Bosnia and Herzegovina. In case of issuance of a multiple-entry visa the applicant is obliged to provide adequate travel health insurance covering the period of the first planned visit.

For minors: in addition to the aforementioned documents, birth certificate is necessary or court decision on legal custodian/guardian. Visa application form for minors must be signed by both parents or legal custodian/guardian. For minors traveling without parents or legal custodian/guardian, authorization statement for travel with designated person (made

in notary office in English, Bosnian/Croatian/Serbian language), signed by both parents or legal custodian/guardian is needed.

NOTE: Visa application must be submitted no later than 15 days before the start of the planned visit.

For submitting visa application at the Embassy it is necessary to make an appointment by the telephone or e-mail.

VISA FEE: Both single and multiple entry short stay visas (visa C) cost 60 EUR.
